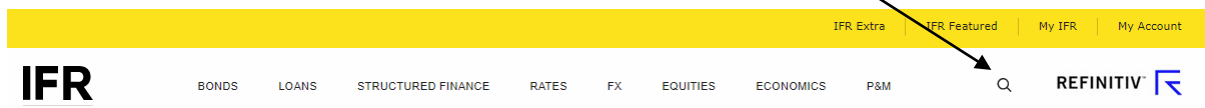


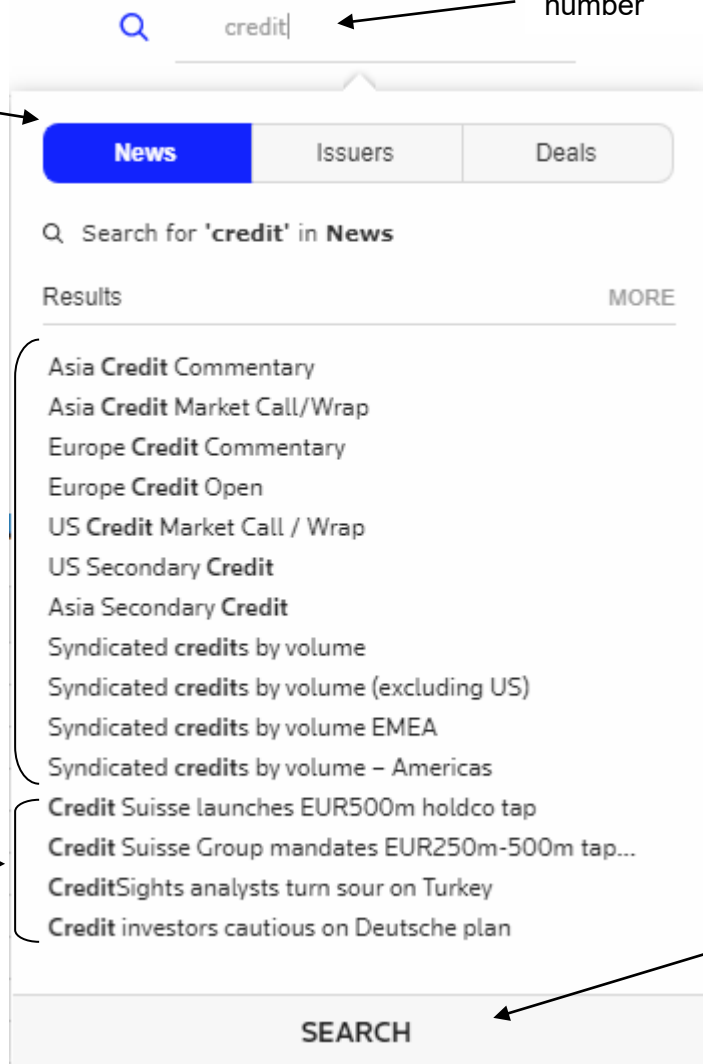
How to use Search
